

FRP & FRS SERIES ARCHITECT'S AND ENGINEER'S SPECIFICATIONS*

Radiant Infrared heater(s) shall be supplied by QMark®, a Marley Engineered Products® Brand, Bennettsville, SC, USA and shall be of the kW rating, voltage and phase specified in the schedule. They shall be infrared type heating units, certified to cETLus, listed for wall, ceiling, and fully recessed ceiling mounting, and designed for indoor or semi-outdoor mounting.

HEAT EXCHANGER: Elements shall be metal sheath, quartz tube or quartz lamp, as specified in the heater schedule, radiant heating type that transmit infrared rays generated by the heavy duty coiled element inside. The quartz tube units shall have high thermal shock characteristics that make it exceptionally well suited for outdoor use with exposure to the elements. Elements shall be equipped with pigtail leads for more positive connections in severe conditions.

ENCLOSURE: All housing and hardware shall be constructed in one of two options: (RP Units)—20g galvaneal steel, polyester powder-coated with a high temperature powder coat finish or (RS Units)—20g type 304 stainless steel with a brush finished. Construction shall be a two-piece design that allows one person installation of the upper mounting support separately, to allow rough-in wiring. The heater section shall be constructed with tabs specifically designed for connection to the upper mounting support, by one person, for finish wiring. For recessed mounting needs, each enclosure will come with a complementing architectural trim, matching the finish of the heater or another specified finish, and creating a clean, unobstructed appearance.

REFLECTION: Reflectors shall be one-piece, snap-out, minimum .030 bright polished anodized aluminum with a beam angle of 30°, 60° or 90° symmetrical, or 60° asymmetrical, as specified in the heater schedule and for optimal heat coverage.

MOUNTING: All units are listed for wall, ceiling, and fully recessed ceiling mounting applications. Each wiring compartment and housing are reinforced with hardware for those installations where the elements of wind and rain become a factor. For recessed mounting, units come standard with an architectural trim for a clean, unobstructed appearance, as well as a supplemental bracket for ease of installation. Adjustable tilt mounting brackets additionally available.

CONTROLS: A full line of controls and control packages are available. Please contact your local Marley Sales Representative for additional information.

OPTIONAL ACCESSORIES AND EQUIPMENT: The optional field installed offering includes bulb wire guards, tilt adjust mounting bracket, wall mounting bracket, recessed trim kits, and red Vycor sleeves for quartz lamp elements.

Bronze finish is not intended for direct salt spray exposure in marine applications or highly corrosive greenhouse, swimming pool, chemical storage or industrial atmospheres. Maintain at least 5 ft. in radiant path, between bottom of heater and combustible material. Pigtail element leads for a more positive connection in high-traffic areas where physical abuse.

MOUNTING CLEARANCES

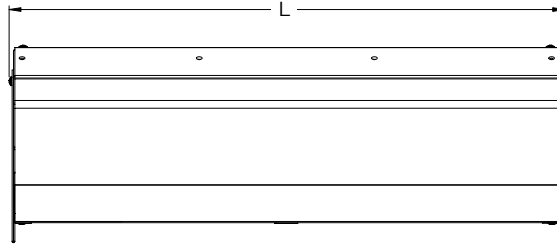
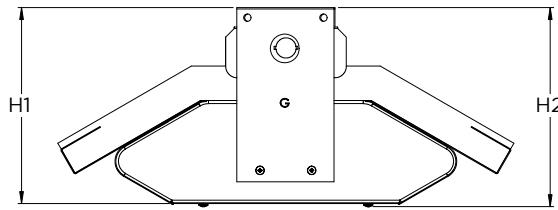
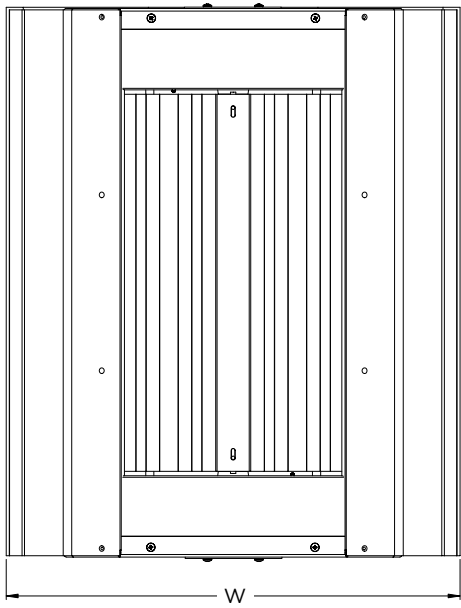
